SUBJECT : AMENDMENTS TO THE BIDDING DOCUMENTS

Pursuant to the CEZA BAC Resolution No. 10-03-2020 and as discussed during the Pre-Bid Conference held on October 8, 2020, the Bids and Awards Committee hereby issues the following amendments:

1. Please be noted that the purchase price of the complete set of the Bidding Documents in the Invitation to Bid for the Supply and Delivery of Brand New and Branded Motor Vehicle is Twenty-Five Thousand Pesos (Php 25,000.00) and not Ten Thousand Pesos (Php 10,000.00).
