



## INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF FOUR (4) UNITS BRAND NEW AND BRANDED PICK-UP VEHICLE

1. The **Cagayan Economic Zone Authority**, through the **Approved Corporate Operating Budget 2020** intends to apply the sum of **Six Million Five Hundred Thousand (Php 6,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Four (4) units Brand New and Branded Pick-up Vehicle**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Cagayan Economic Zone Authority** now invites bids for the **Supply and Delivery of Four (4) units Brand New and Branded Pick-up Vehicle**. Delivery of the Goods is required **within Ninety (90) calendar days upon receipt of the Notice of Proceed**. Bidders should have completed, within **the last three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

In addition, Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **BAC Secretariat** of the **Cagayan Economic Zone Authority** and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 27, 2020 to September 16, 2020** from the address below and upon payment of **Ten Thousand Pesos (Php 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Cagayan Economic Zone Authority** will hold a Pre-Bid Conference on **10:00 AM, September 4, 2020** at **CEZA Board Room, 10F Greenfield Tower, Mayflower**

**cor. Williams Sts., Highway Hills, Mandaluyong City, Metro Manila**, which shall be open to prospective bidders. All prospective bidders are advised to join the Pre-Bid conference via webinar which will be posted on CEZA website before **10:00 AM, September 4, 2020**.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **5:00 PM, September 16, 2020**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
8. Bid opening shall be on **10:00 AM, September 17, 2020** at **CEZA Board Room, 10F Greenfield Tower, Mayflower cor. Williams Sts., Highway Hills, Mandaluyong City, Metro Manila**. Bids will be opened in the presence of the bidders' representatives via **webinar**. Late bids shall not be accepted.

In view of the IATF Guidelines, specifically on the limitation of the number of persons allowed in meetings, bidders' representatives shall be prohibited to be physically present in the bid opening.

9. The **Cagayan Economic Zone Authority** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
