#### SUMMARY

1. This has reference to CEZA Memorandum Circular No 02-2019 dated February 18, 2019 with subject: Mandatory Use of Tug Boat Assist During Berthing in relation to PPA Administrative Order No 08,s 2012 for Pilot Special Services Charges and PPA Administrative Order No 11 s 2000 for Mandatory use of Tug Boat Services.

2. Pursuant to above references, the undersigned with the CEZA port Operations Specialist Mr ralph Iloy and Port Harbor Pilot Capt Reynaldo Erica initiated a consultation meeting with different shipping agents, transport officers, tugboat company representative and other stakeholders on March 6, 2019 at 10:55 am at Country Inn Beach Resort, Sta. Ana, Cagayan.

3. At the outset, Mr. Ralph Iloy declared that CEZA will implement PPA Admin Order No 11 s 2000 and PPA Memo Order No 8 s 2012 for CEZA not to violate Port International Safety Procedures. This will be done pursuant to CEZA Memo Circular No 2-2019 and will be effective March 15, 2019. (Minutes hereto attached)

4. One Tug Boat Company, Sevenwells Tugs and Towing Services based in Subic, Zambales submitted a proposal for tugboat services at a rate of Php 1,800,000.00 for berthing (in and out).

5. North Harbor Tugs Corporation represented by Operations Manager Ronald Custona verbally manifested their intention to submit a counter proposal at a rate lower than mentioned above. The undersigned gave them fifteen (15) days, sufficient time to make good on their intentions but up to this date, no proposal has been submitted.

6. Meanwhile, the other stakeholders interposed no objections to the implementation of CEZA 'No Tugboat Assist, No Berthing' Policy as embodied in

annuan Office of the Administrator & CEO MAR 25

CEZA Memorandum Circular 02-2019 but merely stated that their respective cost of operations will considerably increase.

#### DISCUSSION

7. Both the undersigned and CEZA Port Operations Specialist are of the opinion that the port users and stakeholders must be consulted on the 'No Tugboat Assist, No Berthing' Policy in Port Irene and Port San Vicente.

8. This is also true on the Provider and Rate of Tugboat Services that is available. However only one such provider, Sevenwells Tugs and Towing submitted a formal proposal. The other company reneged on their promise to submit theirs within 15 days.

#### RECOMMENDATION

9. Respectfully recommend that CEZA Port Operations immediately implement Memorandum Circular 02-2019 (No Tugboat Assist, No Berthing Policy) and adopt SEVENWELLS TUGS and TOWING Services as a non-exclusive provider.

10. Further recommend approval and signature on attached CEZA Operations Circular to operationalize paragraph 9, above.
