Please be informed of the following in response to the requests for clarification that the Cagayan Economic Zone Authority (CEZA) – Bids and Awards Committee (CEZA-BAC) received during Pre-Bid Conference and/or at least ten (10) days prior to the deadline of submission of bids, as prescribed by Section 22.5 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 for the CEZA's procurement of civil works project entitled "Design & Build Scheme – Re-Construction of San Vicente Causeway and Wharf at the Cagayan Special Economic Zone and Freeport":

- 1. Attached is our conceptual layout/plans for the proposed San Vicente Causeway and Wharf with dimensions. These drawings should provide minimum basis for the bid plans and cost estimates.
- 2. As instructed by the Commission of Audit Team Leader assigned to CEZA, the checklist of requirements is to be released to prospective bidders that have already purchased the bid documents. Said checklist instructs which documents should be included in the bid submission. All other documents mentioned in the bid documents but were not included in the checklist will be submitted afterwards only by the Lowest Calculated Bidder during post-qualification and the declared Lowest Calculated and Responsive Bidder after the issuance of the Notice to Proceed.

Please be reminded that since this procurement project is a design and build scheme, therefore all draft bid plans and design drawings submitted during the bidding process are to be finalized after the issuance of the Notice to Proceed and prior to the actual construction.

- 3. The 5,000 DWT is the minimum requirement not the "up to" requirement
