

**“A RESOLUTION REQUIRING ALL CEZA LOCATORS ESPECIALLY THE CASINOS TO ESTABLISH THEIR RESPECTIVE QUARANTINE AND ISOLATION FACILITIES FOR THEIR OWN PUMs AND PUIs CASES AS SUPPORT TO THIS LGU HAVING LIMITED RESOURCES TO COMBAT COVID-19 PANDEMIC”**

**WHEREAS**, while quarantine protocols have been slowly easing up, number of POSTIVE COVID-19 cases are filing-up;

**WHEREAS**, as the IATF-MEID and public transportation authorities have allowed the resumption of transportation on a reduced capacity, towns and provinces without earlier cases of COVID-19 are now becoming agitated, aggravated by the seemingly unregulated coming home of Locally Stranded Individuals (LSIs) from Metro Manila and other areas known to have escalating number of positive COVID-19 cases;

**WHEREAS**, as per record given by the MHO, positive COVID-19 cases incurred by this locality are those who have outside travel history;

**WHEREAS**, the Municipal IATF have previous issues on quarantine protocol violations with some inbound personnel of Casino Establishments that indeed created panic to the local residents in the earlier stage implementation of related quarantine protocols;

**WHEREAS**, this LGU established Quarantine/Isolation Facilities as required but it is anticipated to be insufficient if the unregulated coming home of LSIs will further increase and Balik Probinsya Program continues;

**WHEREAS**, caught financially unprepared with this pandemic, this body is constrained to seek the support of CEZA Locators especially the Casino Establishments for the establishment of additional Quarantine/Isolation Facilities;

**NOW THEREFORE, BE IT:**

**RESOLVED AS IT IS HEREBY RESOLVED**, to require all CEZA Locators especially the Casinos to establish their respective Quarantine and Isolation Facilities for their own PUMs and PUIs cases as support to this LGU having limited resources to combat COVID-19 pandemic.

**RESOLVED FURHTER**, that copy of this resolution be furnished to CEZA Administrator Atty. Raul L. Lambino and DOH-Regional Office 02 thru Dr. Cesar B. Cating, the Acting MHO for their information and proper intervention.
